As we traversed this challenging and very successful year, it was you who made our success possible. Your faith in this institution is unstoppable!

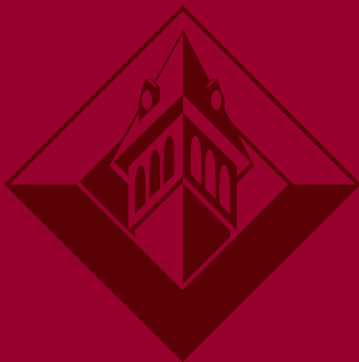
Here are just a few examples of what you helped us achieve this past year:

- ◆ VCSU was ranked the “No. 1 Public Regional College in the Midwest” for 2018 by U.S. News and World Report for the 3rd consecutive year and a U.S. News “Best College” for the 20th consecutive year.
- ◆ We have enjoyed record enrollments: fall 2016, 1,452 students; spring 2017, 1,407; and summer 2017, 633. And how about fall semester 2017—an all-time record of 1,522!
- ◆ We began our Master of Arts in Teaching program—which allows a college graduate to earn a graduate degree and teaching credentials—and enrolled 18 students in its first year. Outstanding!
- ◆ The 2016–17 scholarship allocation of \$1.375 million helped fuel our enrollment growth, and in 2017–18, we increased the scholarship allocation to a record \$1.425 million!
- ◆ Our V-500 scholarship program exceeded its annual goal by more than \$58,000, and the Scholarship Auction raised more than \$80,000!
