Required Minimum Distributions after age 70 1/2

IRA Charitable Rollover Remains intact with New Federal Tax Bill

Congress passed and the President signed into law new Income Tax legislation prior to the close of 2017. Although there were many significant changes, one attractive provision in the federal tax code that has not changed is the IRA Rollover option.

If you are looking for a way to make a big difference and support our students, the IRA Rollover is your answer! If you are 70 ½ or older, you may be interested in a way to lower your income and taxes from your IRA withdrawals. An IRA charitable rollover is a way you can help continue our work and benefits this year.

Benefits of an IRA Rollover:

- *Avoid taxes on transfers of up to \$100,000 from your IRA to the VCSU Foundation
- *Satisfy your required minimum distribution (RMD) for the year
- *Reduce your taxable income even if you do not itemize deductions
- *Make a gift that is not subject to the 50% deduction limits on charitable gifts (changing to 60% in 2018)

How much must I take out of my IRA at age 70 1/2?

According to the Internal Revenue Service, required minimum distributions (RMDs) must be taken each year beginning with the year you turn age 70 1/2. The RMD for each year is calculated by dividing the IRA account balance as of December 31 of the prior year by the applicable distribution period or life expectancy.

What is a qualified charitable distribution?

Generally, a qualified charitable distribution is an otherwise taxable distribution from an IRA (other than an ongoing SEP or SIMPLE IRA) owned by an individual who is age 70½ or over that is paid directly from the IRA to a qualified charity.

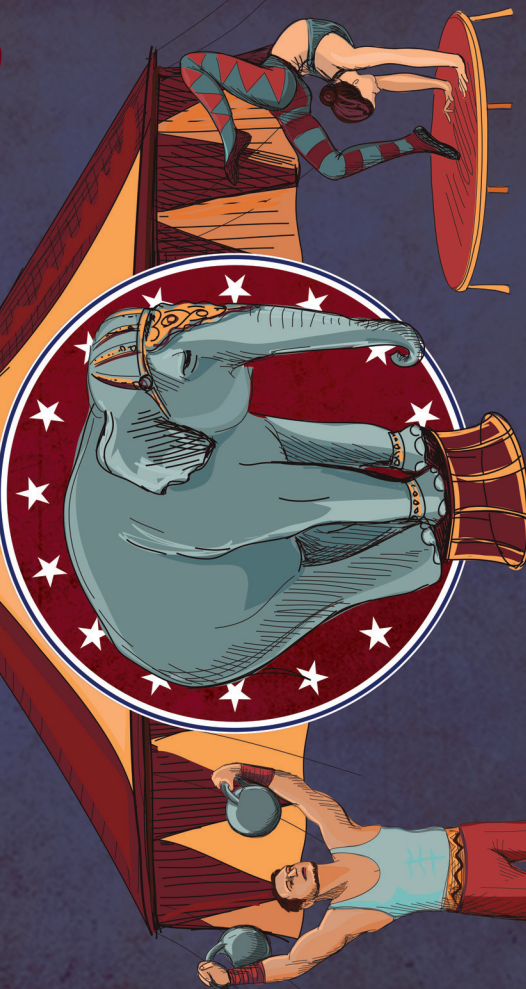
