Do you know that...?

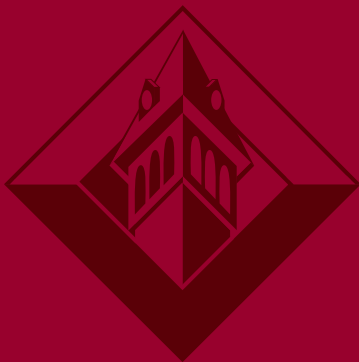

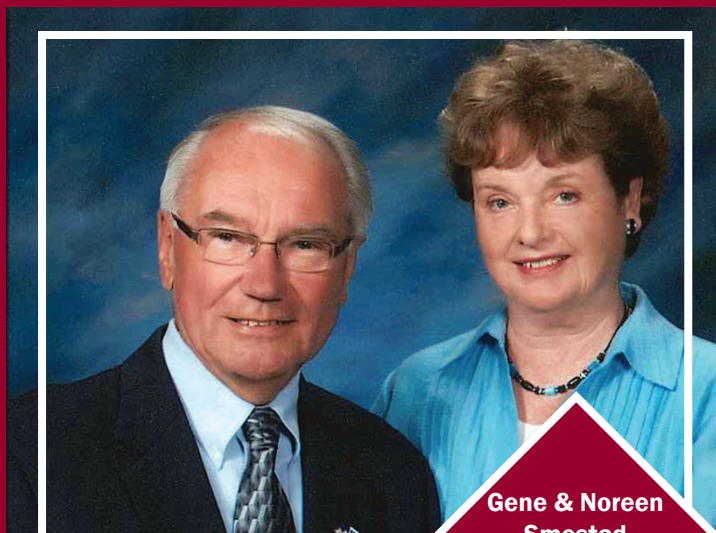
